THREE-YEAR-OLD KINDERGARTEN 2021 APPLICATION INFORMATION GENERAL ENROLMENT PROCEDURES

1. Application for a Place

- Enrolment applications will be accepted one (1) year in advance of the year your child will attend the three-year-old program. You may enrol your child the year he/she is turning two.
- Enrolment application forms are available from the Kindergarten or via the website and must be completed in full and include:
 - Copy of the child's Birth Certificate or Passport;
 - Immunisation History Statement; and
 - Payment of the enrolment application fee.
- A separate application form must be completed for each child.
- To facilitate the inclusion of all children into the program (refer to the Inclusion and Equity Policy), enrolment applications should clearly identify any additional or specific needs of your child.
- A copy of your child's birth certificate or passport must accompany all applications. Fairy Hills Kindergarten Association Inc, requires children to have turned three years old on or prior to the 27th January 2021 (the year they commence the program) to attend the three-year-old program. Children turning three-years-old between the commencement of Term 1 and 30th April will only be able to commence the program upon their third birthday.
- Siblings that are currently attending the Kindergarten should be listed on the enrolment form. Due to demand for places we no longer consider siblings that have attended previously.
- All applications must be accompanied with the <u>non-refundable</u> enrolment application fee (paid via direct deposit).

- Completed enrolment application forms are to be forwarded to the Enrolment Officer at the Kindergarten.
- Access to completed enrolment application forms will be restricted to the Enrolment officer (or delegated person), Staff, President and Secretary, unless otherwise specified by the Committee of Management.
- Applications will be entered on to the Kindergarten waiting list using the eligibility and access criteria.

2. Closing dates and Procedure for late applications

- Not applicable.
- Due to the high volume of applications received we do not send out individual confirmation notifications.

3. Allocation within Groups

 Places within our three-year-old programs will be allocated on confirmation of acceptance by the Enrolment Officer these are preferences only; the ultimate decision is made by the Kindergarten and will be final.

4. Offer of Places

- Places will be allocated to enrolled applicants in accordance with the eligibility and access criteria of the Kindergarten.
- All enrolment applications that are successful will be notified (in writing) of the confirmed place.
- Parents/Guardians who do not wish to accept the offer of a place, or intend to withdraw their enrolment, will be requested to notify the Enrolment Officer in writing as soon as possible.
- Second and Third round enrolment offers will be made 2 and 4 weeks after First round offers respectively.

5. Children turning three during the year

• Children can only commence the program when they have turned three years old. Children who turn three after 31st January 2021 will be offered a place if a vacancy is available.

6. No Jab No Play Policy

• Fairy Hills Kindergarten adheres to the "No Jab No Play" policy. Further information can be found at https://www2.health.vic.gov.au/public-health/immunisation/vaccination-children/no-jab-no-play

7. Toileting

• We strongly encourage children to have commenced toilet training and be out of nappies and pull-ups prior to attending kindergarten.
